

## RULES FOR PARTICIPATION IN THE FOURTH EDITION OF

# INTRECCINCANTIERÈ

### FOREWORD

*Manifattura di Domodossola*, a leading textiles company for over 100 years, is sponsoring the **INTRECCINCANTIERE** competition for young artists and students of design courses and art schools. The competition is being run in collaboration with *Lineapelle* and *Gruppo Banco Popolare* and is aimed at discovering new talent and the future key players of the *Made in Italy* brand.

### Art. 1 – Requirements

The competition is open to Italian and foreign young designers under thirty years of age. No academic qualification is required.

### Art. 2 – Objective

Participants must use *Manifattura di Domodossola* braids to create finished products destined for the *Leather Goods, Interior design, Footwear, Clothing and Jewellery* sectors. The prizes will be awarded as follows:

- No.1 prize to the *Best overall creation*;
- No.1 prize for the *Best Leather Goods creations*;
- No.1 prize for the *Best Interior design creation/project*;
- No.1 prize for the *Best Clothing creation*;
- No.1 prize for the *Best Footwear creation*;
- No.1 prize for the *Best Jewellery creation*.
- No.1 prize *Lineapelle's guests*;
- No.1 prize *Manifattura di Domodossola*.

### Art. 3 – Registration

To register, please send the attached form, filled out in all parts, via E-mail to [pressoffice@manifatturadomodossola.it](mailto:pressoffice@manifatturadomodossola.it), or through our website [www.manifatturadomodossola.it](http://www.manifatturadomodossola.it) in *Intreccincantiere* special section.

Please only fill out one or other of the sections *Individual registration* and *School registration*.

Each group or competitor is asked to indicate the sector in which they intend to compete.

The registration must be received no later than 22 December 2017.

### Art. 4 – Projects

Under the supervision of a single teacher, participating school groups may submit up to 5 different prototypes. The objects may be made individually or in small groups. The teachers are therefore invited to make an internal selection and submit only the 5 best projects/creations to the competition.

Anyone wishing to compete individually or in a group (maximum three people) may register; only one project may be submitted in both cases.

The projects must be accompanied by a short presentation describing the idea and the aims.

The projects must be original and unpublished, failing which they will be excluded from the competition. For the Interior design sector only, participants may submit a paper project; an actual prototype must be submitted in all other cases.

Participants in **INTRECCINCANTIERE** will be entitled to be acknowledged as the authors of the projects.

*Manifattura di Domodossola* may not be held liable for any models which are received damaged or are lost.

### **Art. 5 – Materials**

All young people interested in the competition may view the *Manifattura di Domodossola* materials at the company itself (Villadossola - VB), and also at *LP Fashion Studio* (Milano). The search, final choice and selection - free of charge - must be made at the premises of *Manifattura di Domodossola*.

Participants are reminded that *LP Fashion Studio* is only an exhibition space for company materials and the materials therefore may not be taken from there. Participants who obtain their materials at *Manifattura di Domodossola Spa* will have the chance to choose from among thousands of articles available.

Anyone who is unable to go to the company for personal or logistical reasons may, by prior agreement, have samples sent to them. The choice of these materials will be made from a selection of articles decided by the company and sent via E-mail. For creation of the prototypes, materials other than *Manifattura di Domodossola* products may be included, but the company's own products must always play a central role in the composition.

### **Art. 6 – Deadlines**

The items must be received no later than 2 February 2018 at the following address:

### **Art. 7 – Exhibition and judging**

The objects created will be exhibited and judged during the *Lineapelle* event (Fieramilano – Rho) from 20 to 22 February 2018, at the *Manifattura di Domodossola* booth.

### **Art. 8 – Jury**

According to these regulations, the creations sent will be judged by a jury, which will award the following prizes (*Best overall creation, Best Leather Goods creations, Best Interior design creation/project, Best Clothing creation, Best Footwear creation and Best Jewellery creation*). The jury will be formed of highly qualified members from the fashion world and

from the specialised press. The jurors' names will be published at a later date. The jury itself will appoint its president.

Amongst all the creations, Lineapelle's visitors will award the *Lineapelle's guests* prize. *Manifattura di Domodossola's* Style department will be pleased to give a prize too.

### **Art. 9 - Communications**

We suggest our participants to follow us on our Facebook (*Manifattura di Domodossola* and *Concorso Intreccincantiere* pages) and Instagram (*@manifatturadomodossola*) profiles for future communications.

### **Art. 10 – Prizes**

Prizes will be awarded through plaques and cash prizes, as follows:

- The *Best overall creation* will receive a cheque for € 1000;
- The *Best Leather Goods creation* will receive a cheque for € 700;
- The *Best Interior design, Clothing, Footwear and Jewellery creation* will each receive a cheque for € 500,
- The *Lineapelle's guests* prize-winner will receive a cheque for € 300;
- The *Manifattura di Domodossola's* prize-winner will receive a cheque for € 500 together with the opportunity to serve an internship into our company.

*LP Fashion Studio* will take custody of the winning prototypes, which will be exhibited at the subsequent trade fairs on the *Lineapelle* network.

### **Art. 11 – Award ceremony**

Winners will be informed of the place and date of the award ceremony at a later date, in time to allow them to arrange to attend.

### **Art. 12 - Rights on use, information, disclosure of the results**

*Manifattura di Domodossola Spa* is authorised to publicise the initiative with the national and international press and to promote the results of the competition with the activities it considers most appropriate. All participants hereby authorise *Manifattura di Domodossola Spa* to exhibit their project during events and exhibitions. The participants also authorise *Manifattura di Domodossola Spa* to publish their project in all communication, in a virtual gallery on [www.manifatturadomodossola.it](http://www.manifatturadomodossola.it), on social networks, in a catalogue, a book and/or the specialised press; nothing will be due for this, except the obligation of citing the authors.

### **Art. 13 – Return of projects**

At the end of the competition, the projects which are not chosen will remain in the custody of *Manifattura di Domodossola Spa*. The winning creations and a selection of the others will be exhibited at the company stand during the *Lineapelle* event (Fieramilano – Rho) in October 2018. Subsequently, and on the participants' request, all creations will be returned to their legitimate owners. Prototypes remaining unclaimed at December 2018 will become the company's property.
